Frequently Asked QUESTIONS

Can you tell me a little more about the Church Management Certificate Webinar Program?

There are 12, 90-minute web seminars presented by Villanova University's Center for the Study of Church Management, Our Sunday Visitor, and AmericanChurch. This ecumenical series will help pastors, staff and leadership of all religious denominations. Each webinar will be conducted at two different times on the date scheduled, at 2:00 pm Eastern and at 7:00 pm Eastern. If participants have access to the internet, they can attend/view the webinar and listen through their speakers.

Is the webinar interactive?

Yes. Participants can ask questions and share insights through a designated Q&A section on the webinar screen.

What if I only want to participate in a few of the sessions individually?

There is an option for participants who do not want a Church Management Certificate to purchase and view individual webinars for \$99 per session. In addition, there is an option to purchase and view recorded webinars at a later date through our secure portal.

What are the requirements to earn the Church Management Certificate?

Participants must pay the \$849 course fee, attend all 12 sessions, submit and pass the required coursework for each webinar. Coursework consists of a three-page typewritten paper with the subject of how each session either applies or will be applied in the participant's work at a church, or church-related organization.
